1 Preamble

This Release Note introduces the **TC35i Terminal Release 03.01**. The document describes new and improved features and known issues.

To meet the legal demands according to the European Directives 2002/95/EC (RoHS) and 2002/96/EC (WEEE) the hardware platform of TC35i Terminal has been redesigned with this release. Along with this change, a new power amplifier was introduced. The benefit of the new power amplifier is a more stable current consumption versus antenna impedance. Furthermore, the SIM interface was optimized for electrical testing on the ORGA IT3 platform according to the "3GPP TS 51.010-1" specifications. The general performance regarding compliance with GSM Standards remains unchanged.

Please note that TC35i Terminal Release 03.01 and all later firmware releases cannot be loaded into TC35i Terminals based on the previous hardware releases. Likewise, older firmware (up to Release 02.20) cannot be loaded into the new hardware platform.

2 New and Improved Features

AT command / feature	Brief description
AT^SCFG, parameter "Call/SpeechVersion1"	This parameter specifies or queries the indication of Half Rate and Full rate support within the bearer capability information transmitted from the terminal to the network. On power-up, priority is given to Full Rate. Alternatively, the Half Rate codec can be preferred or disabled.
AT^SCFG, parameter "Radio/Band"	This parameter specifies or queries the frequency band(s) the TC35i Terminal is allowed to use.
AT^SCFG, parameter CSD/SendLLC	This parameter enables / disables the transmission of the optional LLC information element (Low Layer Compatibility) during mobile originated ISDN data calls.
AT^SCFG, parameter Call/ATS0/CSV	This parameter effects the configuration of Autoanswering set with ATS0. You can choose whether ATS0 applies both to voice and circuit switched data calls, or to circuit switched data calls only.
AT^SNFG Generate Tone	The AT^SNFG command generates local sine tones on the audio interface currently selected with AT^SAIC and AT^SNFS. Up to three different tones can be composed by changing the duration, frequency and amplitude.
AT+CSSN	To meet the demands of 3GPP TS 51.010 test cases the "+CSSI" URC now covers a greater range of notifications for call forwarding.



3 Important Notes

AT command / feature	Brief description
AT^SCFG, parameter "AutoExec"	In rare circumstances automatic command execution may fail when the option "wait for all calls have ended" is used. This behavior applies to commands with network dependent activities, such as sending a short message.
SMS storage AT+CPMS	This issue applies only to TC35i Terminals shipped from factory. As specified in [1], the delivery default of the preferred SMS memory storage is "SM" (= SIM card). This default setting is correctly indicated by the read command: AT+CPMS? +CPMS: "SM",0,30,"SM",0,30,"SM",0,30 OK Nevertheless, received short messages will be routed to the "ME". So, trying to read from "SM" only returns an empty storage: +CMTI: "ME",1 AT+CMGR=1 +CMGR: 0,,0 OK Workaround: To resolve the problem it is necessary to reconfigure the SMS storage of new devices by executing the AT+CPMS write command and switching, only once, to another SMS storage type, e.g. AT+CPMS=x,x,"MT". Afterwards, you can keep the new setting or change it again at any time to set your own preferences. Example 1: To select another SMS storage: AT+CPMS="MT,"MT","MT" +CPMS: 0,55,0,55,0,55 OK # Remember that "MT" is the sum of "SM" and "ME"
